Greetings, Haverford neighbors!

Welcome to the June-Moon-Croon-Spoon issue of our neighborly newsletter, the last before a two-month hiatus over July and August. Relaxed and refreshed, your Editor will be back at the keyboard again in September. But before the break, here's a rundown of what's been happening this month.

Township Commissioners' Updates

Capital Ideas: Commissioners will workshop Lower Merion's capital improvement plan on June 26. It's your chance to let the commissioners know what your own capital improvement priorities are. The meeting will be held in the Board Room of the Township Administration Building, starting at "approximately" 6 p.m. You can attend in person, but if you want to attend via Zoom or comment via email, contact Jody Kelley, Township Secretary, at (610) 645-6145 or publiccomment@lowermerion.org before noon on the day of the meeting.

Piazza Development Still Developing: The proposed development of the property along the south side of Lancaster Avenue in Ardmore between Ardmore and Greenfield avenues has hit a rough patch. Piazza Auto Group, which owns the Acura and VW dealerships currently sited on the parcel (there's also a shuttered I-HOP), will likely be looking for a new partner after Toll Bros. pulled out earlier this year.

Once slated to be Ardmore's biggest apartment complex, the development is looking to downsize and diversify. But the clock is ticking. If work isn't underway in time, the development will have to meet more restrictive code requirements adopted in 2020 that would no longer permit the 5- and 6-story structures originally planned.

Redistricting Redux: After Montgomery County rejected Lower Merion's attempt at redistricting last year, the issue is back on the table. Redistricting happens every 10 years, after the U.S. Census figures are released. The lines of political subdivisions are redrawn to account for any geographic redistribution of the population, with the aim of keeping the population of districts roughly equal.

The 2020 U.S. Census showed the township's population grew by almost 6,000, to 63,633, necessitating a redistricting of its 14 wards. The 14 township commissioners each represent one ward. Lower Merion hired an expert consultant to help draw new ward boundaries, but the county said the new maps "did not respect magisterial district boundaries" and had to be redrawn.

Here Comes the Sun: At their May 23, 2024, meeting, the Montgomery County Board of Commissioners announced the awardees of the 2024 round of Montco 2040 Implementation Grant funding. Lower Merion Township was awarded the maximum quantity of \$250,000 for the Ludington Library Solar Installation Project.

The project will result in the installation of a photovoltaic (PV) solar array on the lower roof of the library, as well as two ground-mounted PV solar canopies over portions of the library parking lot. The green roof located on the upper roof of the library will remain intact.

This project will be the Township's second solar project, the first being a 156.2 kW (184,000 kWh) system at Penn Wynne Library that is expected to be completed in Fall 2024.

Federation of Civics

(Haverford is a member of the township-wide Lower Merion and Narberth Federation of Civics. We send a-delegates to their meetings and report back on what's doing.)

Here's to Your Health: The Federation of Civics was the latest stop on Main Line Health's traveling rollout of its mega development on the site of the former St. Charles Boromeo Seminary. Having bought the 73-acre campus in 2019 from the Roman Catholic Archdiocese of Philadelphia, the suburban health system wants to erect a "health and wellness village" there, including a sizeable commercial component, over the next decade.

Nearby residents worried about increased traffic and other potential adverse consequences have voiced their concerns at previous presentations. Main Line Health has responded by downsizing some components of the development and changing traffic patterns.

While preserving the historically protected buildings and nonreligious statues on the former campus, the "village" is expected to include

- medical offices
- senior housing
- condos
- multifamily housing
- a boutique hotel
- retail shops
- trails & open space

Rising Waters? Aqua Pennsylvania has notified customers that it wants to raise rates by 20 percent or more for the average customer, citing the cost of infrastructure upgrades. The Pennsylvania Utility Commission is reviewing the rate hike request. If approved, the new rates could take effect as early as next February.

A formal proposal will go out in September. The timing is auspicious, given -the Township Commission recently formed an Ad Hoc Traffic Safety Committee and the new Superintendent of Police is said to be open to prioritizing traffic safety. Not to mention the township's Traffic Safety Unit is working up a list of hazardous intersections to be considered for installation of red-light cameras.

Night Out: This year's National Night Out Festival will be held Tuesday, Augus 6, from 6 to 9 p.m. in the Wynnewood Shopping Center. Wow! So much to do and see: music, food, carnival rides, face painters, jugglers, magicians and more! And of course plenty of impressive police and fire equipment.
